Description of Nature, Purpose and Beneficiaries of Project:

DWR staff will be performing their annual cathodic protection survey from Devil's Den Pumping Plant (DEPP) to the California Coastal Water Authority (CCWA). To do this work, staff will test various vault locations using handheld survey equipment. To access each site, staff will travel in a standard size pick-up truck on established paved and dirt farm roads. This work is estimated to take a crew of 2 DWR personnel approximately 2 days to complete. Work is estimated to take place between February 24 to March 7. This work is necessary to monitor the integrity of the State Water Project's infrastructure.
