Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Retail License submitted on 12/8/2017 by Elizabeth Tabor.

Project Activities:

The Project will consist of a cannabis retail store located at 408 South Mount Shasta Blvd, Mount Shasta, CA 96067. The APN is 057-392-090-000. It will operate out of an existing 3049 SF building and will occupy 2400 SF for cannabis activities. The lot area is approximately 8375 SF. Hours of operations are 9am-7pm during the winter and 10am-8pm during the summer. There are no other cannabis activities on site. The zoning designation is C-2, general designation.
