The California Department of Transportation issued a District Director’s Order to replace failed culverts in Glenn and Yolo County along State Route 45 at PM 3.2, PM 8.62, and PM 16.25. The proposed work consists of mobilization, replace the failed culvert with new RCP culvert, roadway excavation, backfill, cold plane AC pavement, place HMA, place RSP, water diversion, striping, traffic control and incidental work.

- Test for asbestos containing material (ACM) per all rules and regulations for the culvert. Properly handle and dispose of asbestos containing material, if found.
- Other issues including aerially deposited lead (SSP 7-1.02K(6)(j)(iii)), treated wood waste (SSP 14-11.14), and/or thermoplastic/stripping (SSP 36-4 or 84-9.03B)

Right-of-Way:

All staging occurred within Caltrans Right-of-Way.

Disposal/Borrow:

Based on the scope of work, there was no disposal that required a borrow site.

No Permits:

Based on the scope of work, regulatory permits were not required.

Consultation/Coordination:

Coordination with the USFWS occurred for giant garter snake (GGS). Based on the scope of work and due to the nature of the project, formal consultation was not required. Preconstruction surveys were conducted, and a qualified biologist was onsite during construction. No GGS were observed.
