Project Title: Cub City, LLC (Project)

Project Location: The Project is located at 3195 Regional Parkway, Santa Rosa, in Sonoma County (059-210-024-000).

County: Sonoma County.

<u>Project Description</u>: The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code, Section 26012, approved a Small Indoor commercial cannabis license submitted on September 11, 2018, by Cub City, LLC.

<u>Project Activities:</u> The Project will consist of 10,000 square feet of cannabis cultivation, including both mature canopy and immature/nursery cultivation. Additional approved and continuing operations include processing, and packaging. Indoor cultivation and processing operations may occur 24 hours per day, as needed, though generally will occur between 8:00 am and 4:30 pm. Deliveries are limited to the hours of 8:00 am to 5:00 pm Monday through Friday. The current approved employee number of 22 will remain unchanged. The modification does not involve any new construction. The parcel is located within an existing 19,590-squarefoot commercial building on a 1.02-acre Heavy Industrial parcel.
