DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

In order to retain Local Land use authority, the State requires Sonoma County to develop and maintain a Local Coastal Program to regulate land use and protect coastal resources in compliance with the Coastal Act. On July 17, 2023, the Board of Supervisors approved Sonoma County's Local Coastal Plan, the land use plan of the Local Coastal Program. On November 14, 2024, the California Coastal Commission voted unanimously to conditionally certify the Board adopted LCP, subject to modifications recommended by Coastal Commission staff. On February 4, 2025, the Board of Supervisors adopted the Local Coastal Plan as certified by the Coastal Commission.

REASON WHY THIS PROJECT IS EXEMPT:

The project is statutorily exempt from the California Environmental Quality Act (CEQA) as per Sections 15250, 15251 (f), and 15265. CEQA does not apply to activities and approvals pursuant to the California Coastal Act by any local government, necessary for the preparation and adoption of a local coastal program.
