Tentative Tract Map No. (38652) PLN23-0077 proposes a subdivision of 37 lots with duplexes for a total of 74 units on a 75.26 acre parcel north of the Ridgemoor Road and Boulder Crest Way intersection. The project proposes preserving 63.4 acres (approx. 84%) of the project site as natural open space and constructing the duplexes on the eastern 16% of the project site adjacent to the existing homes.
