Caltrans proposes to perform Capital Preventative Maintenance (roadway repaving) and bridge replacements on U.S. 101 from post miles R1.9 to R9.7 in Monterey County. The primary scope of the project is to rehabilitate and extend the service life of the pavement on the roadway and shoulders within the project limits, replace the San Antonio River Bridges (44-0141L/R) at post mile R6.6, and replace the southbound North Bradley Undercrossing Bridge (44-0142L) at post mile R7.9.
