Project Title: The Emerald Connective LLC (Project)

Project Location: The Project is located at 015-410-068 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project will consist of 10,000 square feet (sf) of Mixed-Light Tier 1 cannabis canopy housed in (6) six existing greenhouses, (2) off stream water storage ponds, and associated support buildings totaling up to 23,912 sf. The applicant is proposing the addition of one Greenhouse adjacent to the existing greenhouses to replace the existing immature plant area and a future untimed addition of a 60' x 100' Harvest Storage and Processing Building.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
