Standard Coastal Development Permit to gravel a driveway, install a 640 square-foot modular single-family residence with a deck, install a roof-mounted solar system, an 80 square foot storage shed, a pump tank, construct utility hookups, a fenced garden area, and remove two dead trees. In addition, the project proposes to install a culvert pipe under proposed driveway to connect drainage ditch.
