The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution, Manufacturing, and Cultivation Licenses submitted on 12/1/2018, 12/28/2018, and 2/13/2020 by ELSA ENTERPRISES.

Project Activities:

The proposed project will operate a distribution, manufacturing, and cultivation license out of an existing facility located at 10648 ARMINTA ST W, SUN VALLEY, CA 91352 (APN 2466-031-021). The applicant will store cannabis products for distribution, non-volatile manufacturing, and small indoor cultivation in 5,390 square foot facility. The project will receive water and power from Los Angeles Department of Water and Power.
