An application has been received by the Calaveras County Planning Department requesting an Administrative Use Permit (AUP) to install a new unmanned wireless telecommunications tower (monopole) and supporting ground equipment. The request includes installation of a new 125-foot (ft.) stealth mono-elm with twelve (12) antennas, an emergency back-up generator, and associated small equipment. All facility equipment will be contained within a 40 ft. by 30 ft. fenced lease area located approximately 100 ft. from the nearest property boundary and approximately 400 feet from the nearest inhabited structure. The subject parcel is located at 10039 Camanche Parkway in Wallace, APN 048-018-014, is located in Section 14, T4N, R9E, of the MDB&M.
