Project Title: Santa Clara River at Lost Boys Project (Streambed Alteration Agreement, No. EPIMS-LAN-24591-R5)

Project Location (Los Angeles County): The Project is located within the Santa Clara River, in the County of Los Angeles, State of California; Latitude 34.416671, Longitude -118.576363, Latitude 34.424388, Longitude -118.569994, and Latitude 34.422983, Longitude -118.557261; Assessor's Parcel Numbers (APN) 2866-007-907, 2866-007-078, 2866-007-902, 2866-007-910, 2811-083-902, 2811-065-903, 2811-065-911.

Project Description: The California Department of Fish and Wildlife has extended Streambed Alteration Agreement EPIMS Notification No. EPIMS-LAN-24591-R5, pursuant to Section 1602 of the Fish and Game Code to Southern California Edison (Permittee) as represented by Hazem Gabr.

The Project involves the maintenance of vegetation to a set distance from Southern California Edison (SCE) owned and operated power lines. The Project will take place along a portion of SCE's 220 kV Pardee-Sylmar No. 1 and No. 2 Circuit, the 66 kV Saugus-Appgen-Newhall Circuit, and the 66 kV Saugus-Newhall No. 3 Circuits. This extension changed the initial expiration date of the Streambed Alteration Agreement from February 24, 2024, to February 24, 2026. This extension also included conditions to the original Streambed Alteration Agreement in the form of revisions to the project's permanent impacts being lessened from 12.54 acres to 0.501 acres, with the addition of 0.39 acres of temporary impacts. This also resulted in the reduction to the required letter of credit amount associated with the mitigation of the project's permanent impacts. Reasons why Project is exempt: The Project consists of the maintenance of vegetation to maintain set clearance distances with SCE's power lines. No expansion of use is proposed. The Project is exempt because it involves the maintenance of existing structures and/or facilities and involves fuel management activities within 30 feet of structures to reduce the volume of flammable vegetation.
