A tentative subdivision map to subdivide approximately 48.6 acres in four phases, or units, for development of 143 single-family residential lots. Units 1 and 2 would take primary access from Oasis Road would connect to Units 3 and 4 through an intervening parcel via an access road and Units 3 and 4 would take primary access from Gold Hills Drive via Pleasant Hills Drive. The Project includes dedication of a road right-of-way along the northeastern boundary of the project for the future construction of Shasta View Drive as well as dedication of the Dry Gulch Creek corridor along the west boundary of the subdivision as open space for recreational and trail purposes, and will include a dog park. The Project will be responsible for off-site construction of Road A within a dedicated easement from the subdivision to Oasis Road for development of Unit 1 and off-site construction of Pleasant Hills Drive to Gold Hills Drive if not already constructed at the time of development of Unit 2. The Project also necessitates construction of off-site sewer at the southeast corner of the project boundary to connect existing infrastructure to the project.
