Project Location: The Project is located at 526 Top of the Grade, Douglas City in Trinity County, CA 96024.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis small outdoor License.

Project Activities:

The Project area encompasses approximately 38,400 square feet (0.88 acres) occupying most of the predominantly eastern section of the parcel. The Project would operate up to 9,600 square feet (sf) of existing outdoor mature cannabis comprised of 150 cultivation boxes and 624 square feet of support structures. Water for the project would be provided from an onsite well. An onsite septic system would serve the Project's wastewater needs.
