Description of Nature, Purpose, and Benefits of Project:
 The goals of this 4.8-acre project are to increase riparian habitat, remove invasive plant species, reduce erosion, and engage the local community in conservation practices and restoration science. The project would include the removal of Tier 1 invasive plants and the establishment of native vegetation along the creek bank. The long-term revegetation goal is to enhance mid-story and ground-level complexity along the stream. The project will enhance wildlife habitat connectivity and thermal refugia for a diversity of birds, mammals, amphibians, and other wildlife. The plant palette will reduce the vulnerability of wildlife to phenological mismatches by increasing the number of months and the amount of resources (cover, food) that are available.
