The Proposed Project would modernize the Ventura Compressor Station by replacing three existing natural-gas-driven compressors with two new natural gas compressors and two electric-motor-driven compressors. The Proposed Project would also install a new 10,458-square-foot compressor building; new 4,641-square-foot office building; and new 5,459-square-foot warehouse. The existing compressor equipment and temporary office facilities would be decommissioned approximately one year after the new facility has become fully operational.
