The existing timber bridge must be replaced to support commerce, continue access to the Quechan Reservation and the Bard community, as well as provide a safer crossing of the Yuma Main Canal. Therefore, Imperial County Department of Public Works has requested that an Initial Study (IS #24-0037) be prepared.
