**Description of, Nature, and Purpose of Project:**

The Alameda County Public Works Agency project includes pavement resurfacing and pedestrian ramp installation and sidewalk repairs on Grant Ave, Maubert Ave, 162<sup>nd</sup> Ave, Los Banos, Esteban St, Paseo Grande, Saint Johns Dr, Sait Johns Ct and Colonial Dr. The project would include; milling existing asphalt concrete, repairing asphalt concrete base failure, applying asphaltic emulsion; furnishing, placing, and compacting 2” asphalt concrete surfacing; placing roadway signage and striping; new drop inlet grates as needed; and installing pedestrian ramps, minor curb, gutter, and sidewalk repairs. All BMP/water pollution control measures and cleaning of the job site would be conducted. All work will be done within existing road right-of-way. The purpose of the project is to repair the roadway, improve drainage, and provide access and safety for pedestrians consistent with the Americans with Disabilities Act (ADA).


