Description of Nature, Purpose and Beneficiaries of Project

The County of San Luis Obispo Department of Public Works (County) proposes to apply micro-surfacing to multiple County maintained roads. Approximately 38.63 miles of roadway will receive micro-surfacing treatment. The objective of this project is to improve the condition of these roads, maintain a smooth riding surface, and ensure safe access for motorists. Work will include traffic control, removal of existing pavement markings, application of micro-surfacing, and restriping.
