**NOTICE OF INTENT TO ADOPT
A MITIGATED NEGATIVE DECLARATION**

Public Resources Code Section 21092 and Cal. Code of Regulations Title 14, Section 15072 (the Guidelines for the California Environmental Quality Act) require a local agency to provide a notice of intent to adopt a negative declaration or mitigated negative declaration to the public, responsible agencies, trustee agencies, and the county clerk of each county within which the proposed project is located, sufficiently prior to adoption by the lead agency of the negative declaration or mitigated negative declaration to allow the public and agencies the review period provided under Section 15105 of the Guidelines.

Project Title: Lorne Project (ENV-2019-3203-MND)

Project Location: 11146 – 11148 Lorne Street, Los Angeles, California, 91352

Project Description: The project includes a Zone Change from R1-1-CUGU to (T)(Q)RD1.5-1-CUGU. The project involves the demolition of 3 existing single-family dwellings units for the construction use and maintenance of a 17-unit apartment with attached garages on an approximate 11,339 square foot lot.

Schedule: The City of Los Angeles will receive comments on the Mitigated Negative Declaration (MND) for 30 days beginning March 13, 2025 and ending April 14, 2025. The City of Los Angeles, as lead agency, will make a determination on the project, following a public hearing to be scheduled.
