Description of Nature, Purpose, and Beneficiaries of Project:

The encroachment permit applicant, CVIN, is proposing to conduct environmental survey work in Tulare County along State Route (SR)198 from Post Miles 21.76 to 18.77 and along SR 65 from Post Miles 39.577 to 38.08 north of the City of Exeter. Work will include windshield surveys, with occasional stops in designated pull-out areas to review and account for sensitive species. A notice will be placed behind the vehicle during stops for safety. All vehicles will remain within the maintained shoulder (graded/shoulder backed areas). No ground disturbance, vegetation disturbance, or wildlife trapping is permitted. Caltrans will issue an encroachment permit (06-25-6-SV-0341) for the survey work within State right-of-way.
