

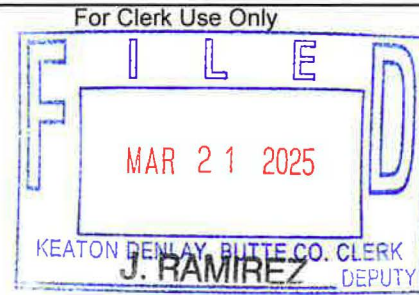

Project Title: 2026 Road Rehabilitation Project – E. 20th Street from Park Avenue to Notre Dame Boulevard (Capital Project # 50495)

Project Location – General: Chico, Butte County, CA

Project Location - Specific: E. 20th Street from Park Avenue to Notre Dame Boulevard

Description of Project: The 2026 Road Rehabilitation Project will improve the existing roadway segment of E. 20th Street from Park Avenue to Notre Dame Boulevard (approximately 1.6 miles). Proposed work includes pavement reconstruction and resurfacing, crack sealing, dig-outs, re-striping, reducing travel lane width, upgrading bicycle lanes to include green paint and a buffer zone, ADA compliant curb ramps, new signage, and repairing sections of broken sidewalks, curbs, gutters, drainage features, and sewer system facilities. Additionally, approximately 280 feet of the existing 12 inch sewer line along Franklin Street will be replaced with a 15 inch sewer line in the same location.

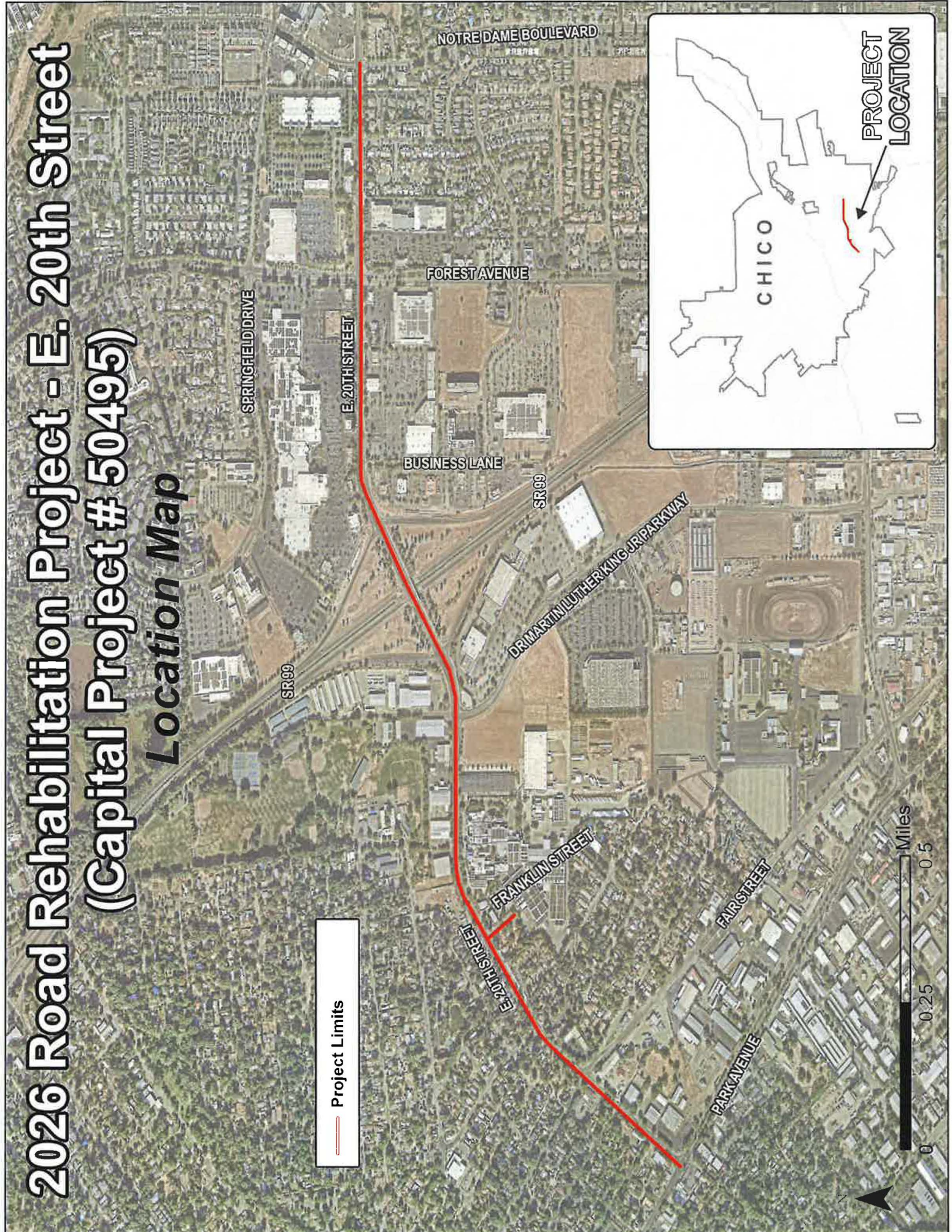

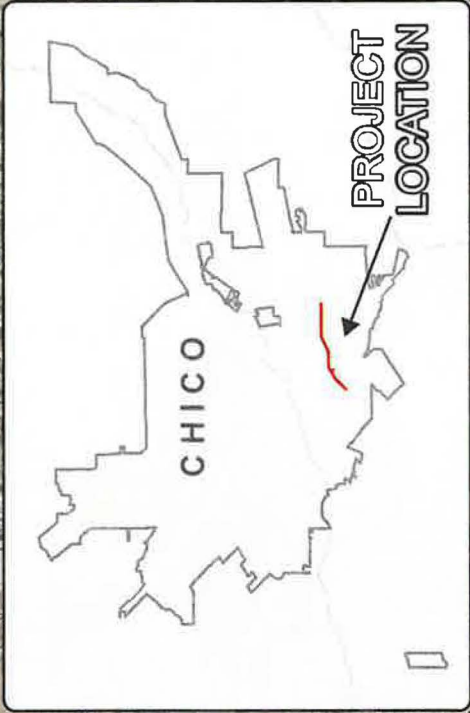
