Southern California Edison (SCE) proposes to do utility work on State Route 190 (SR-190) in Tulare County at several locations between Post Miles (PM) 22.361-22.603. The locations are east and west of the SR-190's intersection with Head Quarters Dr, PM 22.55. Within the State right-of-way, the project proposes to replace poles, equipment, and wires at 6 locations. Two of the locations will require DSDDs. The anticipated excavation depth is 36 inches, and the width is 24 inches. Caltrans would issue an encroachment permit to allow for the proposed work to occur within State right-of-way.
