The California Department of Transportation (Caltrans) initiated a Director’s Order for the purpose of closure and detour of traffic on State Route 70 at post mile (PM) 14.38 in Yuba County. This project was needed to protect vehicular traffic from the Hotel Marysville building that sustained structural damage in a fire on June 15, 2024. Caltrans proposes mobilization, traffic control, detour setup and incidental work.
