Description of Nature, Purpose and Beneficiaries of Project: This project will involve the resurfacing of street pavement within Centennial Drive, from Lacey Boulevard to 225' north of Merrit Street. Improvements to include recycling of the existing pavement, adjusting manhole and gate valve covers, installing communication conduit, installation of accessibility ramps, asphalt concrete paving and restriping of the roadway. The existing pavement on Centennial Drive is cracking and failing and in need of rehabilitation. This project will extend the useful life of the street by approximately 12-15 years.
