The project proposes a Coastal Development Permit (CDP), Site Development Permit (SDP), and a Multi-Habitat Planning Area (MHPA) Boundary Line Adjustment (BLA) for a new 16,251-square-foot (sf) 2-story single dwelling unit over basement, accessory structure, pool, and associated site improvements (i.e. hardscape and landscaping) on a vacant lot located at 2072 Via Casa Alta. The 0.77-acre site contains Environmentally Sensitive Lands (ESL) for sensitive biological resources and steep slopes, is located in the RS-1-1 Zone and Coastal Overlay (Non-Appealable) Zone and is designed Very Low Density Residential (0-5 DU/AC) and Parks, Open Space within the La Jolla Community Plan area.
