Caltrans proposes a Bridge Rail Replacement project on the I-15 near Fallbrook in San Diego County to reconstruct damaged bridge rail and enhance safety of motoring public. Project work will consist of removing damaged concrete using hand tools, forming barriers with plywood forms, and using concrete trucks to pour concrete when forming the barrier.
