The City of Ventura proposes to replace the existing Main Street Bridge over the Ventura River. In addition to the bridge replacement, the project would include two vehicle lanes, sidewalks, two 5-foot shoulders and a barrier protected Class I bike path. The project is located approximately 0.25 mile north of U.S. 101 and adjacent to SR-33 in the City of Ventura. The limits of the project are between Peking Street to the east and and Park Access Road to the west.
