Project Location: The Project is located at 3505 Cadillac Ave., Suite F5, Costa Mesa, CA 92626, in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 6/27/2019, by Walton Chan. SW Ventures, LLC, applied for a Manufacturing Type 6 Non-Volatile Extraction License in an existing facility.

Project Activities:

The proposed project will operate a Manufacturing Type 6 Non-Volatile Extraction license within an existing building at 3505 Cadillac Ave., Suite F5, Costa Mesa, CA 92626 (APN 139-661-03). The cannabis activities include preparation, non-volatile extraction, manufacturing processing, packaging, storage, and distribution of cannabis products. The manufacturing operation will occupy and improve an existing industrial building totaling 7,178 square feet, with only minor interior improvements and no changes to existing use proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
