Big Canyon County Club plans to renovate its golf course (1) to fully replace existing irrigation facilities nearing the end of their useful life with a state-of-the-art irrigation system to enable efficient, more targeted irrigation and minimize the potential of overwatering, (2) to correct areas of minor drainage deficiencies, and (3) to update the golf course while the course is closed to play during implementation of the irrigation project.
