The project would involve construction of 11 residential buildings and five mixed use buildings on the project site; as well as four, single story, above ground enclosed parking garages (other on-site parking is further discussed in the paragraph below). The project would include a total of 96 residential units arranged as rowhouse and stacked dwelling units with one, two, or three bedrooms. The project would also include 5,005 square feet (sf) of live/work space and 18,755 sf of commercial space, including a 2,500 sf cafe/restaurant.
