Project Title: Big Bear Tennis Court Rehab

Project Location: This project is located at Big Bear Sports Ranch, 2080 Erwin Ranch Road, Big Bear, CA 92314, with APN Number 031523121.

Project Description: This project involved the construction of two (2) tennis courts and the rehabilitation of one (1) tennis court, but not limited to supplying and installing missing chain link fence, excavating and compacting the subbase and base course, providing moisture barriers, non-extruded expansion joint fillers, non-sag sealant or self-leveling sealant to fill the gap, provide a new 5" thick dark, green-colored concrete slab with reinforcement bars, 3-to5-foot-wide earth swale or re-grade the low-lying spots along the perimeter side of the newly poured concrete slab, remove and replace the existing concrete entryway, demolishing and disposing of the existing asphalt pavement on one (1) existing tennis court, including all construction debris.
