The purpose of the 2025 RTP/SCS is to provide a clear vision of the regional transportation goals, objectives, and policies in the Lake Tahoe Basin. The RTP provides short-term and long-term transportation strategies for implementation, which includes realistic and fiscally constrained alternatives. The purpose of the SCS is to demonstrate the integration of land use, housing, and transportation for the purpose of reducing GHG emissions from passenger vehicles. The 2025 RTP/SCS is an update to the current 2020 RTP/SCS adopted in May 2021. The 2025 RTP/SCS reflects minor changes that occurred since adoption of the 2020 RTP/SCS. The 2025 update to the 2020 RTP/SCS focuses on continued implementation of the 2020 RTP/SCS, with minor updates to policies, programs, and projects to ensure consistency with federal, State, and local planning requirements.
