A Tentative Parcel Map to divide a single RD-5 lot, in the Stockton Boulevard NPA, from a 1.52-acre lot into four residential lots (0.17-, 0.12-, 0.12-, and 0.87-acre). The project would result in four residential units consisting of the existing unit on Parcel 1 and construction of three new units with one on each of the remaining parcels. During development of the new housing units the existing out buildings may be removed or relocated.
