**Project Title:** Timber Harvest Plan "Ranney" 1-24-00176-SON (Streambed Alteration Agreement No. EPIMS-SON-56338-R3)

**Project Location (include county):** The Ranney Timber Harvest Plan (THP) is situated within the Porter Creek Planning Watershed, Sonoma County, U.S. Geological Survey (USGS) Calistoga map, Section 13, Township 8N, Range 7W, Mount Diablo base and meridian. The project area is limited to an unnamed Class III watercourse tributary to Porter Creek, a Class I watercourse.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number EPIMS-SON-56338-R3 pursuant to section 1602 of the Fish and Game Code to the project applicant, Sean Ranney.

The project is limited to the installation of one culvert as denoted in the approved 1-24-00176-SON "Ranney" THP.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on March 28, 2025 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project  will /  will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
