Project Description: (please use a separate page if necessary)

The project proposes a General Plan Amendment (GPA) and rezoning to allow future development of single-family residences on-site at a density that exceeds what is currently allowed under the existing General Plan designation and zoning. The project proposes to change the General Plan land use designation of the site from Low Density Residential to Low-Medium Density Residential, which allows a density of seven to 14 du/ac. The project also proposes to rezone the site from Low Density Residential (R-0) to Low Medium Density Residential (R-2) with a Planned Development (PD) combining district overlay to be consistent with the proposed General Plan land use designation. There is no specific development application on file at this time associated with the proposed project. Based on conceptual plans, the applicant proposes to construct 8 new single-family homes.
