Project Description

The California Department of Transportation (Caltrans) proposes an emergency project to immediately repair a failed culvert system and open trench along State Route (SR) 88 at postmiles 28.33-28.36, in Amador County. The scope of work includes removing the remaining granite subsurface within the trench and installing the manhole at end treatment (ET) #1 as well as placing and connecting an approximately 150' long 24" RCP in the trench and connecting it to the manhole at ET #1. The purpose of this project is to restore function to the drainage system and repair the trench. The project is needed to prevent the loss or impairment of life, property, or essential public services.

 1. Stop all work within a 60-foot radius of the discovery
 2. Protect the discovery area
 3. Notify the Engineer
 4. The Department investigates. Do not move cultural materials or take them from the jobsite. Retain a qualified archeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner should be contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) which will then notify the Most Likely Descendent (MLD). At that time, the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
