The California Department of Transportation (Caltrans) proposes to remove damaged Right- of-Way (ROW) wrought-iron fencing around booster pumps and controllers and replace with more secure fencing consisting of expanded metal along State Route (SR) 99 at Postmile (PM) 27.50 in San Joaquin County and PM R13.33 in Stanislaus County. All work will be within Caltrans Right of Way. The purpose of the project is to address the existing damaged and nonfunctional Right of Way fencing. The project is needed to prevent unauthorized access into Caltrans ROW.

 4. The Department investigates. Do not move cultural materials or take them from the jobsite. Retain a qualified archeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner should be contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) which will then notify the Most Likely Descendent (MLD). At that time, the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
