Description of Nature, Purpose and Beneficiaries of Project:

DWR staff will inspect all culverts along the primary and secondary sides of the CAAQ from Banks Pumping Plant intake channel and Check 1 to Check 8. Following inspections, culverts will be repaired and cleared of sediment/debris as needed with hand tools or backhoe, then injected with high pressure raw water. V-ditches will also be cleaned and reshaped as needed by road grader. Staging and access will be on existing roadways. All work will be within the DWR right-of-way.
