Project Description

Southern California Edison (SCE) proposes the replacement of existing pole 1061974E located within Caltrans right-of-way along State Route (SR-)138 at Post Mile (PM) 5.01, as well as to perform traffic control activities in the City of Neenach/Lancaster, Los Angeles County. Excavation will have a maximum depth of 96 inches, a maximum width of 24 inches, and a maximum length of 2 linear feet. No public utilities will be relocated, and no new right-of-way will be acquired for the project.
