**Project Description**

Southern California Edison (SCE) proposes the removal and replacement of pole #1049001E located along the westbound (WB) direction along State Route (SR) 138 (Lancaster Avenue) at Post Mile 6.058 in the City of Neenach, Los Angeles County. SCE is requesting a temporary encroachment permit to access Caltrans right-of-way to remove and replace pole #1049001E and perform any associated traffic control activities. Excavation will have a maximum depth of 96 inches, an average width of 24- inches, and a length of two (2) feet pole holes. No public utilities will be relocated, and no new right-of-way will be acquired for the project.
