Project Title: Earth Sun LLC (Project)

Project Location: The Project is located at 8490 & 8500 Orr Springs Road (APN 152-030-07 & 151-260-11) in Ukiah, CA.

County: Mendocino

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved both a Small Outdoor and Nursery commercial cannabis license submitted on 1/3/2024 by David Kurzfeld.

Project Activities: The Project will consist of cannabis cultivation on an existing site located at 8490 & 8500 Orr Springs Road (APN 152-030-07 & 151-260-11). The site is zoned Rangeland (RL: 160) and as of 2017, it has been used for cannabis production with no plans for future expansion. Activities that take place include cannabis cultivation (cloning, vegetative growth, and mature flower growth), drying, curing, weighing, packaging, trimming, disposal, and storage. The project will be supported by an onsite groundwater well, an ADA compliant restroom facility, and a solar array for power.
