Caltrans proposes a District Director’s Order Request (DDO) emergency request to repair the abutment slope under Bridge # 57-0422F at the southbound I-5 to eastbound SR-94 connector viaduct, which was damaged by persons experiencing homelessness (PEH). The repairs need to be completed to ensure safety to the motoring public, as any continued digging by PEH will degrade the bridge structures integrity and ultimately, lead to failure. Other project activities include construction area signs, traffic control system, and installing slope paving. All work will occur within State right-of-way. Environmental commitments for visual resources, hazardous waste/materials, and NPDES/Stormwater are included in the Environmental Commitments Record (ECR).
