Description of Nature, Purpose and Beneficiaries of Project:

The proposed Project involves the installation of one stream gage consisting of two poles, approximately 2 inches in diameter, which will be driven into the ground. These two poles will support the necessary measuring equipment. Additionally, a small line will run to the bottom of the river in a trench to measure the water. The installation is expected to be completed in a one-week period during dry creek conditions. Dewatering would not be necessary, no in-water work would be conducted in Deer Creek.

Involves the construction and location of a small structure. The project will involve minor trenching and backfilling, where the surface is restored. No in-water work would be necessary. Stream gage would be used to collect hydrologic data and monitor stream flows. The stream gage would not result in a serious or major disturbance to environmental resources. Therefore, the proposed project meets the requirements of CEQA guidelines 15303, 15304, and 15306 and is categorically exempt from the requirements of CEQA.
