Project Location: The Project is located at 1031 El Camino Real N, Salinas, CA 93907, in Monterey County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 2/26/2025, by Melissa Wight. Cali Love Salinas LLC, applied for a Retail License in an existing facility.

Project Activities:

The Proposed project will operate a storefront retail license within an existing building at 1031 El Camino Real N, Salinas, CA 93907 (APN 133-023-042-000). The storefront retail will occupy an existing building with a total square footage of approximately 1,400 square feet. The Project is serviced by an existing well for water and an existing septic system for sewage disposal. Power is supplied by the PG&E. Building modifications are minimal and no changes beyond existing use are proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
