Project Title: Ruth Coastal, LLC (Project)

Project Location: The Project is located at 7510 Ruth-Zennia Rd. (APN: 020-520-01-00) in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project will consist of up to 10,000 square feet of mature canopy area in ten 10ft x 100ft greenhouses. Five 20ft x 100ft greenhouses & a 32ft x 72ft barn will all contain immature plants. The project will use irrigation water from an on-site 1-million-gallon rainwater catchment pond. Power is provided by less than 50 hp generators.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
