The applicant is requesting a conditional user permit to allow a religious assembly facility utilizing the existing on-site structures. The property includes three residences measuring 2,103.90 sqft, 4,897.96 sqft, and 2,146.14 sqft, along with a 4,979.21 sqft religious gathering hall, a 250.63 sqft garden house, a 125.57 sqft shed, and a 728.63 sqft garage. The facility will host two annual retreats—a 15-day retreat in the fall and a 50-day retreat in the spring. The maximum number of visitors on-site at any time will be 30, with the ten current residents serving as facility employees, bringing the total maximum occupancy to 40. Primary access to the site will be from Two Hills Road
