Project Location: North Fork Lost River, approximately 5.6 miles southeast of Thorn Junction, County of Mendocino, State of California. The project is located in Section 26, T05N, R02W, Mount Diablo Base and Meridian; in the Bear Harbor U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 051-150-003, 051-116-002, and 051-150-004; latitude 39.98994 N, longitude -123.91589 W; 39.99341N, -123.91177W; 39.99596N, -123.90828W; 39.99620N, -123.90805W; 39.99736N, -123.906605W.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-08564-R1C, pursuant to Section 1602 of the Fish and Game Code to April Newlander.

The project is limited to five (5) encroachments: 1 – instream-floodplain enhancement, 2 – Crossing 1 (bridge), 3 – Crossing 2 (bottomless culvert), 4 – tributary and bank restoration, and 5 – terrace ponds.

This is to advise that CDFW, acting as [] the Lead Agency / [X] a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
