Project Title: Fiddymment Bike Trail – Phase 4 (Pleasant Grove Creek) Crossing (Lake and Streambed Alteration Agreement EPIMS Notification No. PLA-24917-R2)

Project Location (include county): The project is located at Pleasant Grove Creek, in the County of Placer, State of California; Latitude 38.794460, Longitude -121.367407; Assessor’s Parcel Number 492-011-001-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number PLA-24917-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, JEN California 15 LLC (Permittee) as represented by Steve Hicks.

This project is limited to the installation of steel piles, concrete bridge supports, and a single span truss bridge. The bridge supports will be small concrete abutments founded on driven steel piles and will be installed from either side of Pleasant Grove Creek. The bridge deck will be concrete with concrete placed in sealed steel forms integral with the steel bridge. The bridge will be erected and installed by a crane in a single piece. The bridge deck will be approximately 250 feet long and 12 feet wide and will be set in place onto the concrete bridge supports.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW’s approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was / was not adopted by CDFW for this project.
