The U.S. Army Corps of Engineers (USACE) and the CVFPB propose to improve approximately 10,580 cumulative feet of levees along the Sacramento River's east levee in Sacramento, California by installing a series of cutoff walls. Levee improvements included in the project were originally analyzed in the American River Watershed Common Features General Reevaluation Report (ARCF GRR) Environmental Impact Statement/Environmental Impact Report (EIS/EIR). This draft Supplemental EIR/Environmental Assessment addresses project modifications and refinements since publication of the ARCF GRR EIS/EIR.
